Idaho Outfitters and Guides Board
Boise, Idaho

JUNE 28, 29, 30, AND JULY 1, 1983

Tuesday, June 28, 1983, a regular meeting was called to order at 0845 in the Boise office boardroom, with Chairman Glen Foster and Members Robert Salter, William Meiners, and Harry Vaughn present. Member Scott Farr was delayed with engine trouble.

William Meiners presented maps and overlays he had ready for the Board. Member Meiners stressed that a standard 1/2 inch map scale be required from licensees with use of watershed and topography bounds but denoting specific location by use of section, township and range. A motion was also made by Member Meiners, with a second by Member Harry Vaughn, and passed THAT THE BOARD WRITE TO EACH FOREST TO HAVE THREE EACH UNFOLDED 1/2 INCH TO MILE ADMINISTRATIVE MAPS MAILED TO WORK UP FOR THE BOARD'S MAP FILE. ALSO TO PURCHASE 42" WIDE MYLAR (@ 30% PRESENT DISCOUNT), 100 FT. NYLON TAPE AND 100 FT. DOUBLESTICK TAPE AT IDAHO BLUE PRINT.

Bureau of Wildlife Chief, Jerry Thiessen, of the Department of Fish and Game came before the Board to explain his Department's Black Bear and Mountain Lion 1981-1985 Species Management Plan which is in process and discuss the Board's moratorium on issuance of new spring bear hunting licenses. Mr. Thiessen recommended that the Board's moratorium be held in effect until their Management Plan was completed on December 31, 1985, but felt the game department's study would not be altered if the moratorium was lifted in Areas #2 and #3 of the Management Plan. A letter will be written in support by the Idaho Fish and Game Department as a followup to this meeting.

Board Member Scott Farr joined the meeting during Mr. Thiessen's appointment.

Also joining the meeting was Conservation Officer Andy Ogden who came in about several inquiries of the same general area coming from the Board for his input, which will be supplied to Director Conley. Wildlife Chief Thiessen also discussed the new backcountry deer tags and the harvest, which the board members advised they supported, prior to both men leaving the meeting.

A motion was made following the meeting, proposed by Member Bill Meiners, seconded by Member Bob Salter THAT THE BOARD ADOPT AS THEIR GUIDELINES THE DEPARTMENT OF FISH AND GAME BLACK BEAR AND MOUNTAIN LION 1981-1985 SPECIES MANAGEMENT PLAN AND IN ACCORDANCE WITH SAID PLAN, THE BOARD DOES REMOVE THE CURRENT MORATORIUM ON BLACK BEAR MANAGEMENT AREAS #2 AND #3 WHILE CONTINUING THE MORATORIUM ON AREAS #1, #4, AND #5 UNTIL DECEMBER 31, 1985. AT THIS TIME RE-EVALUATION WILL BE MADE OF THESE AREAS (#1, #4, AND #5), BASED ON RESULTS OF STUDIES MADE BY THE DEPARTMENT OF FISH AND GAME, AS TO WHETHER TO CONTINUE OR MODIFY THE MORATORIUM.

Signing of "...a license identical to a license held during the previous year" (Idaho Code 36-2109(d)), using the Chairman's name stamp was determined to be a help in expediting issuance of licenses. The Board then instructed the secretary, Edythe Blele, to also sign upgrading of qualification licenses when a guide moved from boatman to lead boatman if he is licensing for rivers under Class III, or if moving to another river. The licenses are considered as not the same, if moving from boating to hunting guiding or vice-versa. Licenses with questionable qualification or other problems will be held for board consideration, but otherwise the Board stressed that licenses not be held up.

Albert Lewis met with the Board and reviewed pending enforcement cases. Also coming in was Ron Moore, ISP, who offered some information as a witness on a case being reviewed by the Board for a hearing.

Outfitter/Guide Business was brought before the Board which included outfitter, Larry Jarrett's meeting with Members Salter and Foster concerning a boundary problem between himself and David Cox, M.A., Double K Outfitters, which left his camp outside his area. A letter will be sent to the outfitters advising them to work out an amicable solution which would also be acceptable to the Forest Service then present it back to the Board for consideration of licensed area change.

Mackay Bar Corporation will be advised that a report had been registered with the Board concerning their jet boat guide, Mitch Sanchotena, operating as a power boat guide on a portion of the Main Salmon River above Ludwig Rapids where he is not licensed.

Kayaking licensing was researched for rule definition and it was determined that clarification was needed in a future rules change. Robert Reed Dowdle license was issued for kayaking.

False documentation supplied for first aid requirement was mentioned as a major problem, also mentioned was the trouble involved in getting Kimberly Richardson her license because of the altered card; it was replaced with a valid one at the last minute. Others were mentioned. A motion was made by Member Bill Meiners, seconded by Member Harry Vaughn THAT THE BOARD PROCEED, AS PROPOSED BY CHAIRMAN FOSTER AND BY PRECIDENT SET BY BOARD PRACTICE, ON ISSUING A LICENSE WHEN CURRENT FIRST AID TRAINING PROOF IS PROVIDED, AND FOLLOW UP ON THE FALSIFIED R.C. CARD. The motion passed unanimously.

A letter of explanation received from outfitter Fred Wright was read concerning first aid cards being updated for his guides. The Board accepted the explanation as extenuating circumstances had been involved, but Mr. Wright will be advised to get the guides valid updated training.

Printing of new letterhead stationery was approved to be ordered; also a re-order of boating training cards.

There was discussion of license fees not being required on new outfitter applications until it was fairly sure they would have approval. It was agreed that a rules wording change would be considered at a future hearing.

The meeting recessed at 1740.

Wednesday, June 29, 1983, the board meeting reconvened at 0835, with all members present.

The amended moratorium on licensing of new bear hunters was again reviewed. It was determined that a list be compiled of all those who had requested consideration since the moratorium was initiated in July, 1981. The moratorium revision will be advised by letter to the Department of Fish and Game and the Idaho Outfitters and Guides Association; also it will be placed in the newspaper as a news item.

The fee increase, effective July 1, 1983, will also be advised to the Idaho Outfitters and Guides Association for notice to the outfitters in the newsletter.

The minutes of April 26, 27, 28, and 29, 1983 were read and then by motion made by Member Scott Farr, seconded by Member Bill Meiners, THE MINUTES WERE APPROVED WITH SUGGESTED CORRECTION IN WORDING.

Mark Henderson, Dan Johnson and Tom Pike, New Meadows, Idaho came before the Board to discuss a possibility of obtaining a big game hunting area in the Krassel Ranger District, Zena Creek area--Units 24,25 and possibly part of 19A. They were especially interested in bear, cougar and predators as they had hounds, but otherwise very little equipment as just getting started. They said they would not withdraw their applications but would consider finishing them later as they may seek another area.

Outfitter Gerald Richie's complainants, Lentz, Dziak and Bellm contacting Member Bob Salter was explained. He said that the other hunters involved, Richard and Grimmelli were satisfied; Ron Lenz and Charles Dziak have each received a check from Richie for \$1,000. Member Bob Salter made a motion, with a second made by Scott THAT RICHIE BE GIVEN A PROBATIONARY LICENSE--1983-84, PROVIDED THAT BOB SALTER CAN CONFIRM THAT BELLM/DZIAK/LENTZ HAVE RECEIVED THEIR SETTLEMENT CHECKS. IF THIS IS NOT CONFIRMED BY JULY 7TH THAT THE RICHIE LICENSE BE DENIED AND HE BE SO ADVISED. The motion passed. The Forest Service will be advised when the license is issued or denied.

Jon Goodman, Salmon, Idaho came in about going into an outfitting business both for himself in the Salmon area for trailrides, backpacking and snowmobiling on his private property and BLM ground, and also into an incorporated business at Moose Creek with Micky Roskelley. The corporate name is now Idaho Big Game Guides, Inc. and both Micky and Jon will be the managing agents. Brett Wooley is no longer involved in the business with Micky Roskelley, which they ran last season as a partnership.

Misc. Board Business was reviewed. A letter will be written in support of the Federal Energy Regulatory Commission Study report; copies were approved to be mailed to the Attorney General's Natural Resource Chief, Pat Kole, National Marine Fisheries, Idaho Department of Fish and Game and Terrance Thatcher, National Wildlife Federation. Also the Bonneville Power Authority request for response was reviewed for input, and a telephone call will be made along with a letter followup.

A letter from State Representative Craig will be replied to concerning his interest in the Board's bear moratorium. A copy of the amended moratorium will be sent.

Albert Lewis came in with information whereby he was given approval to investigate further. Also Al will research with Ada County Prosecuting Attorney a procedure for filing a summons on the people presenting falsified first aid documents to secure a license.

Requests for exception to rules 26.a., and 26.b. were considered for Robert Doppelt, then Member Harry Vaughn motioned, Member Bob Salter seconded, and it was passed THAT ROBERT DOPPELT'S REQUEST FOR EXCEPTION BE APPROVED AS OUTLINED IN HIS LETTER OF JUNE 8TH, WITH THE SAME GUIDELINES AS WERE APPROVED IN 1981.

A letter of operation was read which had been submitted by Carole Finley and Jerry Hughes, also requesting exception for a trip booked with them on the Middle Fork. Member Robert Salter moved, Member Scott Farr seconded a motion THAT EXCEPTION TO RULE 26.a., AS REQUESTED BY CAROLE FINLEY AND JERRY HUGHES IN THEIR LETTER BE APPROVED.

A letter received from Jerry Hughes's attorney, Philip H. Gordon, was read concerning the dispersement of the booked clients deposits now held in a trust fund. A letter had already been mailed, therefore, the attorney will be called in reply.

A letter will be written to Bob Cole, M.A. for Middle Fork Lodge, Inc. and copies sent to Phil Whitely and Brian Simi, M.A.'s for S Bar W Wilderness Outfitters and Bud Hamilton of the Forest Service, concerning the outfitters getting together to work out the area adjustment in the Jackass Gulch to Sliderock L.O. area.

Dale Jennings request for additional area in the Cecil Weddle area for cougar hunting was researched. Then Member Bill Meiners motioned THAT, WITH CONCURRENCE WITH THE SECOND, BASED ON INFORMATION NOW BEFORE THE BOARD I WILL RECIND THE MOTION MADE AT THE JUNE 4TH MEETING CONCERNING DALE JENNINGS. With Member Scott Farr's approval, the motion passed by a majority vote. Then Member Bill Meiners proposed a new motion THAT THE DALE JENNINGS APPLICATION BE APPROVED AS SUBMITTED FOR ONE YEAR PROVIDING THE COUGAR AREA IS APPROVED ON A TRIAL BASIS ONLY. With a second by Member Bob Salter, the new motion passed. Mr. Jennings will be advised that this area is being assigned subject to review at the end of this licensing year.

The Board members considered the increase in fees due July 1st, and determined that with a reasonable attempt to complete the application by the June 30, 1983 deadline with payment of the old fee, these applications will be acceptable without additional fee

The meeting then recessed at 1800.

Thursday, June 30, 1983, all members except Bob Salter reconvened at 0835.

Minutes of June 1, 2 and 3 and 4, 1983 were read, and by motion made by Member Scott Farr, second made by Bill Meiners THE MINUTES WERE ACCEPTED AS READ.

Steven Gale, St. Anthony, Idaho came before the Board to present a valid R.C. card and explain his reason for altering the old card he had presented for a guide's license.

Mike Crevelt, McCall, Idaho dba Backcountry and Beyond, came in to see if licensing was required in his activities he is sponsoring at Quaker Hill, McCall. Others representing the Quaker Hill Conference who also were in attendance were Glen and Jon Koch, Caldwell and Duane Roberts, of Boise. Their brochure and letter will be referred to the Board's counsel, Deputy Attorney General Pat Kole, and they will be advised as to whether their activities come under the Outfitters and Guides law.

Following the lunch recess, all members reconvened with Bob Salter joining the meeting as Olin Gardner, M.A. with James Powell, Idaho Guides Service, Inc. and Salmon River Guides Service, Inc., came in about extending the outfitting license and his guiding for the "Murtaugh" area on the Snake River.

Following review of Charlie Ferdon's request for licensing the upper section of the North Fork of the Payette River, from Payette Lakes outlet to the Sheep Bridge, a motion was made by Member Harry Vaughn, seconded by Member Scott Farr and passed THAT THE BOARD LICENSE CHARLES FERDON FOR THAT SECTION OF THE PAYETTE RIVER, NORTH FORK, BECAUSE MR. FERDON HAD REQUESTED CONSIDERATION BEFORE OTHER APPLICANTS AND HE IS FULLY TRAINED AND QUALIFIED WITH SUITABLE EQUIPMENT AND LIVES IN MCCALL.

Hershel Coulter's request for float boating on the North Fork of the Payette River will be added to the consideration list for license consideration when a space becomes available.

Further consideration was given to Hershel Coulter's request for additional licensed activities to be added to his cougar outfitting. Member Robert Salter called the Department of Fish and Game for input since written input had not been received and Mr. Coulter was requesting immediate license issuance.

Member Harry Vaughn motioned, Member Scott Farr seconded and it was approved THAT HERSHEL COULTER HAVE ADDED TO HIS 1983-84 LICENSE SNOWMOBILING IN AREA PREVIOUSLY LICENSED FOR COUGAR AND PREDATORS. Member Bob Salter motioned and Member Harry Vaughn seconded THAT HERSHEL COULTER'S APPLICATION BE APPROVED FOR ELK, DEER, FISHING AND TRAILRIDES WITH THE PROVISION THAT ALL OF THIS REQUEST INCLUDED IN FISH AND GAME UNIT 24 AND/OR ALREADY LICENSED TO OTHER OUTFITTERS FOR ELK AND DEER HUNTING BE DENIED. FURTHER, (1) THAT THE LICENSE BE LIMITED TO 6 ELK AND/OR DEER HUNTERS PER YEAR, (2) THAT ANY FUTURE SALE OF THE BUSINESS WOULD IN NO WAY GUARANTEE REISSUANCE OF THE LICENSE, (3) THAT HIS REQUEST FOR SNOWMOBILING BE APPROVED IN THE FULL AREA FOR WHICH HE WAS PREVIOUSLY LICENSED FOR COUGAR HUNTING, AND (4) THAT HE BE DENIED FLOAT BOATING ON THE PAYETTE RIVER AS WE ARE ALREADY LICENSED TO THE QUOTA. The motion passed by majority vote.

The meeting recessed at 1750.

Friday, July 1, 1983 at 0830, all members plus, Deputy Attorney General Pat Kole, Chief of Natural Resources met to discuss a number of problems of the Board.

The hearing requested by Attorney Cushman for his client, Steve Alley, was decided to be held in the meeting room of the Attorney General's office, with Chuck Goodenough as Hearing Officer.

A letter, written before Attorney Kole knew the Board's Agent, Al Lewis had returned the deer head evidence, was determined to be a good, direct letter to Prosecuting Attorney Anderson, Owyhee County. Mr. Kole took the letter back to revise before mailing after approval by the Board.

The falsified documents were referred to the Attorney General, he advised that complaints will be filed either in the county where the applicant lives or Ada County, where the offense takes place. The Board recommended a penalty of \$300.00, and if the complaint is ignored, it will be considered again at the time of relicensing.

The bond fee schedule will also be worked on with the Criminal Court committee at a later time during the year. Other items to be looked into were licensing of lake fishing operations, and outfitters leasing guides rather than employing them as guides.

Other matters concerned the language in the Outfitters and Guides Act and the Rules and Regulations which Attorney Pat Kole suggested be corrected by wording changes. September 1st is the deadline to make changes for the wording of the law, as discussed for delegation of license issuance to administrative approval for "same as previously licensed" applicants, and/or removing the fee requirement for new outfitters until a time the license would be approved. A decision will be forthcoming concerning the requirement of managing agents to be licensed as well as the outfitting business.

Outfitter Business was finished following the lunch recess, when all members returned.

Richard English's letter was reviewed along with his license area request. Then, by motion posed by Member Bob Salter, seconded by Member Scott Farr, it was passed THAT THE APPLICATION OF RICHARD ENGLISH BE APPROVED FOR ELK, DEER, TRAILRIDING AND BACK-

PACKING AS REQUESTED EXCEPT FOR AREA LYING SOUTH AND WEST OF CLARKFORK RIVER IN UNIT 4 AND EXCEPT FOR THE AREA IN UNIT 1 LYING NORTH AND WEST OF BONNER'S FERRY PRESENTLY LICENSED TO STANLEY E. SWEET AND TERRY KAYSER.

Member Bob Salter made another motion in consideration of the same general licensing area, with a second made by Member Harry Vaughn, THAT THE APPLICATION FROM GRISSLY OUTFITTERS BE APPROVED FOR ELK, DEER, GOAT AND PREDATORS AND THAT IT BE FOR THE AREA REQUESTED WITH THE EXCEPTION OF THAT PORTION PRESENTLY LICENSED TO RICK VANDERMEYDEN AND JAMES STRIKER. PROVIDED FURTHER THAT THE ELK AND DEER SEASON NOT INCLUDE THE MUZZLELOADER SEASON IN ORDER NOT TO CONFLICT WITH THE LICENSEE, RICHARD GRUNCH OF THE GRUNCH BUNCH.

The license extension request of Member Harry Vaughn to include fishing on the Dwarshak Reservoir was reviewed, and by motion by Member Scott Farr and second by Member Bill Meiners, the motion was passed THAT THIS LICENSE AMENDMENT BE MADE.

The fishing license request for a number of lakes, streams and rivers was reviewed for new applicant Richard Teller, Challis, and also the input received from the Department of Fish and Game. It was then moved by Member Bill Meiners, with Member Scott Farr seconding THAT THE DICK TELLER APPLICATION BE DENIED IN ACCORDANCE WITH IDAHO CODE 36-2109 (b), 4 and 5. This motion was passed, after notation was made of the amount of area already licensed to existing outfitters, tremendous amount of public use indicates the public would best be served by a denial of the license.

Kent Stears, Shelley, Idaho application for additional archery area was researched and a motion was made by Member Bill Meiners, seconded by Member Harry Vaughn, and passed THAT MR. STEARS BE LICENSED FOR HIS ARCHERY HUNT AS REQUESTED IN THE CARIBOU NATIONAL FOREST SOUTHWEST OF PALISADES RESERVOIR PROVIDING THAT SUCH AREA AS REQUESTED IS IN THE CARIBOU N.F. BOUNDARIES AND EXCEPT THOSE AREAS CURRENTLY LICENSED TO OTHER OUTFITTERS. FURTHER THAT HIS APPLICATION FOR BEAR HUNTING BE DENIED ACCORDING TO THE BOARD'S MORATORIUM AS AMENDED JUNE 29, 1983, AND HE BE RELICENSED FOR ARCHERY ANTELOPE HUNTING AS PREVIOUSLY LICENSED.

The application of David Waymire, Howe, Idaho was reviewed and his Fish and Game convictions, then by motion of Member Bill Meiners, second by Member Scott Farr, it was passed THAT THE APPLICATION OF DAVID WAYMIRE BE DENIED UNDER IDAHO CODE 36-2113, PARAGRAPH 6.

George Duncan, Orofino, Idaho application for license extension of area for cougar hunting was researched and approved, but not approved for his bear hunting request. A motion by Member Harry Vaughn, with a second by Member Bill Meiners, and passed as follows: THAT AN EXTENSION BE GRANTED FOR AREA IN UNIT 15 FOR GEORGE DUNCAN FOR COUGAR HUNTING AS REQUESTED IN OLD GEORGE MAY AREA ONLY. BEAR HUNTING IS NOT AVAILABLE AT THIS TIME BECAUSE OF ADEQUATE NUMBER OF BEAR HUNTERS IN THE AREA.

Jim Daude, Gatesville, Texas, request for a license extension was reviewed, and Member Harry Vaughn moved with Member Bill Meiners seconding THAT THE REQUEST OF JIM DAUDE FOR LICENSE EXTENSION FOR BEAR/COUGAR BE DENIED IN ACCORDANCE WITH IDAHO CODE 36-2109,(b)5., AS THERE ARE ADEQUATE NUMBERS OF OUTFITTERS SERVING THE AREA. (Whitten, Walker, May & Galles are currently licensed.

An Outfitter Complaint was reviewed as Member Scott Farr explained a telephone call he received from outfitter Bob Crick. The business is in process of being sold and the Board will require settlement proof at the time of relicensing request. Also Rick Hussey has advised he will settle with his complainant by July 1, 1983.

F.S./BLM/F.&G. Business was reviewed by the Board and letters approved to be mailed. Member Bill Meiners moved THAT THE CHAIRMAN ACT ON THE BOARD'S BEHALF TO REPLY TO THE BUREAU OF LAND MANAGEMENT'S OUTFITTER POLICY. The motion was seconded by Member Harry Vaughn and passed.

License applications were reviewed and approved prior to adjournment at 1930. A list of the licenses issued, extended, amended or denied since the last meeting follows as a part of these minutes.
